COVID-19 Risk Assessment for Marjory Kinnon School

January 2021

Reviewed & Approved by the Chair of the H&S Committee



This Risk Assessment has these underlying caveats:

A) Safety:

The safety of our staff and pupils is a priority. This Risk Assessment minimises the risk but cannot eliminate the risk of infection. The Government have said it is not safe enough for all pupils to be in school. We are currently in a national lockdown until further notice. Only vulnerable pupils or the children of keyworkers will be allowed in school following Government or Union guidance.

B) Prevention:

- 1. **Minimise contact** with individuals who are unwell by ensuring that those who have coronavirus (COVID-19) symptoms, or who have someone in their household who does, do not attend the setting.
- 2. Minimise contact between individuals and maintain social distancing wherever possible.
- 3. **Hygiene:** Clean hands thoroughly and more often than usual.
- 4. **Hygiene:** Ensure good respiratory hygiene by promoting the 'catch it, bin it, kill it' approach.
- 5. **Hygiene:** Introduce enhanced cleaning, including cleaning frequently touched surfaces often, using standard products such as detergents and bleach.
- 6. PPE: Where necessary, wear appropriate PPE. (This applies in specific circumstances. See below).
- 7. Numbers 1 4 must be in place in all settings, all the time.
- 8. Number 5 must be properly considered and settings must put in place measures that suit their particular circumstances.
- 9. Lateral flow testing will be used for all staff and (due to the nature of the SEND needs of pupils) only on the pupils that can tolerate the test.

C) Response To Any Infection:

- 1. Engage with the NHS Test & Trace process. This will involve going to drive through testing on the day of suspected infection.
- 2. Manage confirmed cases of coronavirus (COVID-19) amongst the setting's community.
- 3. Contain any outbreak by following Local Health Protection Team advice.
- 4. Numbers 1-3 must be followed in every case where they are relevant.

D) Flexibility:

This Risk Assessment is a guide. At times a number of staff may be required to cross PODS, BIG BUBBLES and BUBBLES. This will be kept to a minimum but for operational/health and safety/premises/medical/staffing/behavioural reasons, it may not be possible. The Risk Assessment is constantly updated in line with guidance from the Government, DfE, Public Health England and Trade Union guidance.

Tests must be taken within 5-days of symptoms first being shown and the school will remain in daily contact with the symptomatic individual's home to ensure that the test has been arranged/taken and for confirmation of the results. Individuals must self-isolate for 10-days from the date when their symptoms were first displayed and will not be permitted to return to school within that period, unless their test results are negative. If they still have a high temperature after 10-days, they will be asked to keep self-isolating until their temperature returns to normal. Other members of the individual's household (including siblings who may also attend the school) must self-isolate for 14-days from when their family member first becomes symptomatic. They will not be permitted onto the school premises, unless their family member's test results are negative. If tests have not been taken by the 6th day, there is no point taking a test at all and it will be assumed that the individual has been infected with COVID-19 and they will be required to continue to self-isolate for the full 10-days and their household members for the full 14-days. If the test results return positive for anyone becoming ill with COVID-19 symptoms whilst at school, their class bubble will be required to self-isolate for 14-days. The other household members of that wider class or group do not need to self-isolate unless the child or staff member they live with subsequently develops symptoms. If a pupil or staff member tests negative, their symptoms are still indicative of another illness, e.g. cold or flu, and they should not return to school until they are well. Fellow household/class members can end their self-isolation. As part of the national Test & Trace programme, if other cases are detected within the cohort or in the wider setting, Public Health England's Local Health Protection Teams will conduct a rapid investigation and will advise schools an

		appropriate ventilation, where they can be isolated behind a closed door. The room will have a vision panel and a clear line of sight to ensure child safeguarding. Depending on the age and needs of the child, adult supervision may be required. If it is not possible to isolate them, they will be moved to an area which is at least 2-metres away from other people or temporary screens erected. If they need to go to the bathroom while waiting to be collected, they will use a separate bathroom if possible. Before being used by anyone else, the bathroom will be cleaned and disinfected following the cleaning procedures already outlined in this Risk Assessment. If 2-metres cannot be maintained, the member of staff caring for the child while they await collection, must wear appropriate PPE (such as for a very young child or a child with complex needs). 		It will not be possible to maintain distancing when working with many pupils who have complex needs or who need close contact care. Staff will continue to provide the educational and care support to these children as normal.					
		 Children that are old enough and have the necessary comprehension, will be supported to maintain distance and not touch staff and their peers where possible. Where possible, classroom seating has been rearranged so that pupils sit side-by-side and facing forwards, rather than face-to-face or side on. 					
		 Further Measures Throughout the School The school will avoid large gatherings such as assemblies or collective worship with more than one group/bubble. Movement around the school site will be kept to a minimum by keeping children in one consistent classroom whenever possible and having teachers move across classrooms to provide curricular learning, rather than having large numbers of pupils changing rooms at lesson changeover. Break times will be staggered and lunch will follow the arrangements outlined in this Risk Assessment. It is not possible to stagger lunchbreaks sufficiently, for pupils in Secondary so they will have their lunches brought to their classroom. As far as reasonably practicable, the same teacher(s) and support staff will be assigned to each group and these stay the same during the day and on subsequent days. Pupils will sit at the same desk each day if attending on consecutive days. Shared staff spaces have been set up to help ensure staff to distance from each other. Use of these Staff Rooms will be minimised, whilst still allowing staff to have a break of a reasonable length during the day. Groups to access classrooms directly from outside where possible. 					
		One-way circulation in the corridors should be maintained to keep groups apart as they move through the building where spaces are accessed by corridors. The number of persons using the toilet facilities at one time will be limited to ensure that toilets do not become crowded, each POD will have its own designated toilet.
