

The T&L Committee will monitor and evaluate pupil achievement and the quality of teaching, ensuring the school provides a high quality learning experience and delivers a broad and balanced curriculum in keeping with the school's aims, all pupil needs and legal requirements.

The H&S Committee will monitor and evaluate the management of risk within the school and the extent to which the pupils, staff and visitors are kept safe in the school. It will promote the best possible standards of maintenance and estate development, ensuring the school provides a high quality learning experience and delivering as strong as possible set of learning outcomes in keeping with the school's aims, all pupil needs and legal requirements. The Safeguarding Committee will monitor and evaluate the schools safeguarding arrangements and activity to ensure that children are safe, supervised well, attend regularly and punctually and that they behave well. ## **Governing Body Effectiveness & Impact**

#### 1. Focus on governor learning and development and agree development actions

## 2. Review reporting to the governors from school leadership, with a view to streamlining and simplifying evidence and measurement

The Headteacher and Governing Body worked together to agree the scope and frequency of reporting – which included summary versions of the School Development Plan (SD) and Self-Evaluation Framework (SEF).

This met the criteria set out in the Maintained Schools Governance Guide that the governing body:

- Agrees with school leaders on how data will be provided, which will help it stay focused on its strategic functions while being mindful of the impact on workload.
- Identifies ways to validate and cross-reference the data provided by the executive leadership.

A board will need to see information in relation to the priorities it has identified for improvement. This may include data on:

- Pupil learning and progress.
- Pupil literacy and numeracy.
- Pupil applications, admissions, attendance and exclusion.
- Staff deployment, absence, recruitment, retention, morale and performance.
- Quality of teaching.

The HT Report and committee minutes provide and record evidence.

#### 3. Focus on supporting the school leadership through change and re-designation

- Restructure and re-designation featured as priority agenda items at Resources Committees and FGB meetings throughout the year.
- A Governor attended the LBH Task & Finish Group Meeting and was involved in the agreement of the meetings Terms of Reference.
- Governors discussed and approved a new Admissions Criteria and Admissions Policy.
- The GB provided a sounding board and outlet for discussion on the school's decisions.
- The T&L Committee Chair monitored a number of areas linked to the changing curriculum and communication apps for the changing cohort.

#### 4. Continue to explore options open to MKS for academisation

The Headteacher began further exploration and discussion on Academisation with Governors in 2023. The Government were not enforcing academisation but were still committed to the objective. The subject was presented again at the FGB (Summer 2023) where Governors had an opportunity to ask questions on the options open to the school.

- The school held exploratory discussions with a local SAT and Governors were invited to visit and two Governors took up this opportunity.
- The Chair of Governors met with the MAT CEO for further discussion.
- The Headteacher Report provided termly updates to the FGB.

Meetings, external guidance and consultation will continue in 2024-25 and when appropriate, will include information sharing with staff.

## 5. New pathway provision across the school to meet the requirements of the high needs group

Governors at the Teaching & Learning Committee discussed the Curriculum Overview & Bigger Picture PW1/2/3 where the school reported on its planning for the staffing for the first PW3 class in Secondary in September 2023.

The school's focus is now on communication and sensory with a new skills-based curriculum for Pathway 3. MKS are gradually moving away from the subject-based focused curriculum and subject leaders. The school need future leadership roles for Pathway 3.

The SaLT presented to the T&L Committee (1-11-23) on PW3 Alternative Augmented Communication embedded in practices across the school and how this was being expanded to cater for the changing cohort.

The FGB (29-11-23) had requested more information on curriculum pathways. TM/JS gave a presentation on the Social Communication/Emotional Regulation/Transactional Support (SCERTS) framework that underpins all curriculum pathways and teaching and learning for ASC pupils.

The school had completed the self-assessment towards the National Autistic Society (NAS) Accreditation. An interim review of the school and classroom environment with a NAS Assessor had taken place which produced an Action Plan. The T&L Chair had suggested engaging advice from the National Autistic Society so that MKS could record that PW3 was developed "in consultation with NAS".

#### 6. Keep leadership succession under review

As per the Maintained Schools Governance Guide, whilst holding school leaders to account, the governing body is taking reasonable steps to ensure the wellbeing of the Headteacher and the Senior Leadership Team and to support sensible health and safety management.

The governing body is proactive in reviewing a succession plan that addresses anticipated, and possible unexpected, changes in its school leadership so that the school can continue to deliver its strategy and remain effective.
